Where there is more than one nomination for a position there will be a vote.
- In the case of Other Committee positions any member willing to stand will need to be nominated by any two members. This may be done in advance of the meeting or at the AGM itself. Where there is more than one nomination for a position there will be a vote.
- No one may be nominated in writing before the meeting, who has not indicated in writing his/her willingness to stand.
- No one may be nominated at the meeting unless either they are present and confirm that they are willing to stand, or evidence in writing is produced to the meeting of their willingness to stand.
